- 1. Entries must be carved by person entering competition, and carver must rent a table at the show. Judges may not enter carvings in the competition.
- 2. Carvings must be wood. Glass eyes and metal feet are allowed.

3. Mailed or shipped carvings will not be accepted.

The show committee has the right to add, divide or delete categories as deeped necessary.

- Entries are submitted at the sole discretion and sole risk of the owner. The Packard Proving Grounds and Metro Carvers are not responsible for the loss or damage of carvings.
- Group carvings must be mounted on a single base. For judging purposes, the dominant subject will determine the category in which the multi-subject group will be placed.
- Carvings entered in competition will remain in the show room until the show is over at 4PM on Sunday. (Carvings will be returned to their carver's table as soon as practical after judging).

Judges' decisions are final.

9. Metro Carvers has final decision over any and all competition related questions. (Judges decisions are final.)

Carvings entered into competition must have been completed in the last two years.

11. Carvings such as Wood Spirits and Relief Carvings larger than 8" x 8" must have a stand.

12. Each table may enter up to five carvings. Only one entry per category.

13. Ribbons or awards from other shows may not be displayed - NO EXCEPTIONS.

- Entries are submitted at the sole discretion and sole risk of the carving owner. The Packard Proving Grounds and Metro Carvers are not responsible for the loss or damage of carvings.
- 2. Carvings must be wood. (glass eyes, metal feet, or habitat may be of other materials)
- 3. Carvings entered in competition must have been completed in the last two years.
- 4. All entries must be the work of the entering exhibitor including but not limited to the carving, but also the painting, staining, finish, air brushing, etc.
- 5. Mailed or shipped carvings will not be accepted
- 6. Judges may not enter carvings in the competition.
- 7. The show committee has the right to add, divide, or delete categories as deemed necessary.
- 8. Judges may award or withhold scheduled ribbons in a category.
- Metro Carvers has final decision over any and all competition related questions except the judging decisions are final.
- 10. Group carvings must be mounted on a single base. For judging purposes, the dominant subject will determine the category in which the multi-subject group will be placed.
- 11. The entrant is responsible for the correct placement of a carving in its appropriate category.
- 12. Entries must be carved by person entering competition and carver must rent or share a rented table with another carver at the show.
- 13. Persons sharing a table must be present at the registration table and the show to put carvings into the competition.
- 14. Each table may enter up to five carvings with only one entry per category per person.
- 15. Shared table or a Club renting a table count as ONE exhibitor table (only 5 total carvings)
- 16. Carvings such as wood spirits and relief carvings larger than 8"x 8" must have a stand.
- 17. Ribbons and/or awards from other shows may not be displayed NO EXCEPTIONS
- 18. "Best of Show" will be chosen from the first place winning entries of each category except categories 1 thru 5.
- After judging of the carvings is completed, they can be picked up by entrant as soon as practical
 after notification for pickup.
- 20. Carvings entered in competition shall remain (<u>after judging and return to carver is complete</u>) at the carver's table until the show is over at 4PM on Sunday

Entry Procedure

1. COMPETITION ENTRIES MUST BE RECEIVED BY 9:00 AM SATURDAY

- Fill out Carving Competition Entry Form found in your table envelope AT YOUR TABLE. See the form completion instructions attached.
- 3. Present your entry form to the registration table with your carvings.
- 4. Entry person will give you a card for each entry to be attached to the carving such that it is seen on/or attached to the carving. However tape will be available to cover anything that has your name or can be identified as you (logo or ?) on the carving.
- 5. Be sure that card matches the entry form listing.
- You keep the YELLOW COPY which will be used to get receipt of your carving after judging is complete and WHITE COPY will be kept at the entry table.
